Resident alleges RCSC board discrimination

The phrase "which shall be determined by the Board or Management" is discrimination.

When Vance Coleman claims that The Sun City Formula Registry is "unrecognized" even though all of our registrants have RCSC valid rec cards, it is discrimination.

We are not even allowed to say the name of our organization at a meeting but our detractors can and do, always in long-winded derogatory terms.

Our supporters are afraid to be open supporters for fear of retaliation. That's a result of discrimination.

Vance Coleman claims he needs to see our membership list before recognizing us. Did he require that of SCHOA, SCTA, SC Posse, etc.?

The difference between those organizations and SCFR is that we are the "whistleblowers". They don't want to recognize us and give credence to our reports.

We presented the 18-year RCSC employee who proved the cause of the Sundial roof collapse was due to "hidden decay" and not "material defects," which the insurance policy didn't cover. The policy covered hidden decay so the claim got paid.

Yet, at a board meeting, Vance Coleman allowed an imposter who claimed to be representing a well-respected "recognized" organization to say that SCFR almost caused the RCSC to lose the claim for the Sundial roof collapse, which was a lie. Robert's Rules of Order precludes the chair from allowing that kind of discourse, but Coleman claims he doesn't know or have to abide by Robert's Rules of Order yet the bylaws mandate it.

We were lucky to have videotaped the imposter who lied about us so that it could be used to reprimand him and prevent him from doing so again.

Since 2000, SCFR has attended the RCSC meetings. Where was Vance Coleman? His meeting attendance prior to being elected to the board was infrequent, if at all. Within two weeks of getting elected he publicly applauded the actions of the board for raising the PIF to \$3,000 and the quorum that ended membership meetings. They rewarded him with the presidency and the chair of the secret Bid Commission.

Fact: A single member pays \$432 and a spouse pays \$216. The members are not equal and the board cannot write rules that make them unequal.

We demand transparency and accountability. We don't need to be "recognized" to demand that it be done.

Votes should not take place at closed "work sessions," but rather at the open meetings.

All meetings should be streamed live over the RCSC website and archived for future reference. Don't serve if you don't want to be recorded.

Sun Citians may not be able to physically attend the meetings due to infirmity, scheduling, or fear and yet should be able to witness the decision-making process that may negatively impact them.

Inequality and discrimination do not promote a "sense of community," the second tenet of "The Formula for Successful Sun Cities" that Del Webb espoused.

The RCSC policies are ruining Sun City, not our criticism that alerts its victims.
